WAFM Indoor Market Application 2021-2022

The Indoor Market is held 10am - 1pm every Saturday November 6th through December 18th 2021, and then transitions to the first and third Saturday of the month January1st through May 7th 2022 at the Brookfield Town House, 267 Wentworth Rd, Brookfield NH 03872

Purpose – The purpose of the Wolfeboro Area Farmers Market (WAFM) is to promote local agriculture by providing a marketplace wherein locally grown, raised, and/or processed food and farm products are for sale to the public and where educational exhibitions pertaining thereto may be given.

Local – WAFM defines "local" as any product grown or produced in NH or within 50 miles of Wolfeboro.

Fees – Vendors who sign up for the entire winter season (November through May) will pay a reduced fee. The total for the entire season is \$320.00 which works out to \$20.00 per market. The fee should be paid prior to the start of the market in November.

Vendors who sign up for a half season (either November 6th – January 1st or January 15th – May7th) will pay a slightly higher fee. The half season fee is \$176.00 (which works out to \$22.00 per market) and is due prior to the start of the market either in November or January, depending on which half season the vendor is signing up for.

We will be allowing Guest Vendors to attend the market if we have enough room and if they meet all the market requirements (including having insurance). Guest vendors will NOT be a voting member of the WAFM. The fee for guest vendors is \$25.00 per market. Anyone interested in being a guest vendor must complete an application, submit it to the Board, and receive approval prior to attending the market.

If a Vendor wishes to use the kitchen to prepare food for customers there will be an addition \$25 fee per market.

Annual Membership Dues – The annual membership dues are \$15.00 per vendor. If you were a summer vendor, you have already paid the annual dues and you do not need to pay again.

Insurance – All vendors are required to carry Product Liability insurance of \$1,000,000 prior to being allowed to vend. A Certificate of Insurance must be submitted within ten (10) business days of the applicant being accepted as a vendor.
